## **2. Anti-Ragging undertakings Collection Process**

Mandatory online undertakings for every fresher student AND parent/guardian via [www.antiragging.in](http://www.antiragging.in) by August 15, 2025 (before classes commence).

Process: Share unique portal link via admission email/SMS during counseling; conduct live demo in orientation sessions; nodal officer verifies bulk submissions and generates institutional undertaking. No physical affidavits accepted.

Display compliance dashboard (e.g., "1250/1250 students submitted") on college website, notice boards, and NHCE admission portal.

## **3. Anti-Ragging Squad and Monitoring Mechanism**

Constituted -member squads for round-the-clock coverage: 2 shifts daily across boys/girls hostels, canteens, library, parking, buses, and peripheral areas.

Daily patrol logs via dedicated by CCTV footage anonymous complaint boxes at 10 locations; helpline monitoring dashboard.


Zero-tolerance: Any verified case leads to immediate suspension pending UGC inquiry.
