University has received several requests for relaxation in vertical progression for students who are admitted to I semester / I year B.E./ B.Tech. Programmes during the academic year 2021-22 under Regulations Governing the B.E./ B.Tech. Programmes under CBCS -2021 due to introduction of new scheme from the academic year 2022-23. These requests are placed before Joint Board of Studies in its meeting held on 4-11-2022. The Joint Board of Studies recommended to amend the Vertical progression clause of 2021 regulations. The recommendations of Joint Board of Studies were placed before Academic Senate in its meeting held on 15-11-2022. The Academic Senate vide ref (1) above resolved to Amend the Clauses of Vertical progression of Regulations Governing the B.E./ B.Tech. B.Arch. and B.Plan Programmes under CBCS -2021 .

Hence, the amended Clauses of Vertical progression of Regulations Governing the B.E./ B.Tech., B.Arch. and B.Plan Programmes under CBCS -2021 is notified as below:
