2. Proposal and Approval of Scheme of Study for 1st year – AY 2022-2023

Discussion of Scheme of Study for 1st Year UG Program for the AY 2022-2023 based on revised VTU guidelines was tabled. The salient features of the proposed scheme were highlighted in the GCM by Dean – Academics.

- Curriculum is made Industry relevant, Application-oriented and Branch relevant
- Emerging Technologies are introduced from First Year
- Choice Based Credit System is implemented to a larger extent
- Ample opportunities for exploration of Elective Courses by the students
- Implementation of Integrated Courses from the first year
- Foreign Language options are introduced for interested students
- Faculty are trained to handle any courses under ETC and PLC Basket

Also, it was shown that the proposed scheme was in line with the VTU scheme. The detailed scheme of the I year BE, 2022-23 batch (160 credit) was approved in GC meeting.

3. Introduction of new programs

Based on the current market trends, global growth, employability status it was decided to introduce new programmes in the developing fields like artificial intelligence, machine learning, data science, internet of things, cyber security etc., All these trending programmes will increase the opportunities for the future engineers. Gc members unanimously decided to introduce new programmes to add on to the existing programmes in the institution.

4. Closure of programmes

Due to the decrease in the demand and less preference given by the students in opting BE in Civil Engineering, it was decided to close the programme. Also M.TECH in machine design, VLSI were not preferred much by the students. GC approved the closure of the programmes as suggested by the members.

5. Change in intake/ increase in intake

Proposal was put forward to reduce the intake in Mechanical Engineering and increase the intake of Data Science. The proposal was approved in the GC meeting.

6. Infrastructure requirements for AY 2022-23

For the upcoming AY 2022-23, the required infrastructure details were put forward by the Principal. The introduction of new programmes, increase in intake in some programmes and the reduction in intake in few programmes were taken into consideration while calculating the required infrastructure. The details of new laboratories required, additional facilities like faculty cubicle, HOD cabins, other requirements from the departments were taken and discussed. The GC members approved the infrastructure requirements put forward for approval.

7. To discuss regarding application of NBA to UG & PG programme

As per the AICTE mandate, the programmes (60% of the programmes offered by the institution) should be accredited by NBA. It was suggested that PG programmes can apply for NBA. It was decided unanimously in GCM that the department to gear up for the accreditation process and the pre-qualifier to be submitted during the AY2023-24. It was decided to apply NBA under Tier 1 for the two UG programmes BE in Information Science and Engineering and BE in Electrical and Electronics Engineering considering CAY as 2022-23.

8. NIRF Ranking initiative and effort

NIRF ranking framework outlines a methodology to rank institutions across the country. The methodology draws from the overall recommendations broad understanding arrived at by a Core Committee set up by MHRD, to identify the broad parameters for ranking various universities and institutions. The parameters broadly cover "Teaching, Learning and Resources," "Research and Professional Practices," "Graduation Outcomes," "Outreach and Inclusivity," and "Perception". Currently the institution is ranked 121 in the engineering college category. Analysis

was made on which are the areas the institution can improve upon. Research and development needs lot of push and this can improve the ranking of the institution. Policy was made to improve the R&D activities. Incentive policies for quality paper publications, research grants, patent publications, consultancy were proposed in GC meeting. All initiatives taken to improve the R&D activities in the institution were approved in GC meeting.

9. Review of R&D activities- Publications details and discussion

Brief review on the research activities of the institution revealed that the quality publications (in SCI/web of science indexed journals) have increased in the institution. Also, the citations for the year 2022 have increased. The h-index of the institution has seen a good rise compared to the previous year. The faculty members were encouraged through various incentives to increase the quality publications.
