#### **Points Discussed:**

### TCS 2024 Batch Registration

- Low Registration Rate: As of April 9th, 2024, only 45% of students have registered for the TCS drive.
- Mandatory Registration for Unplaced Students: All unplaced students are required to register for the TCS drive. Failure to register will result in disqualification from further placement opportunities.
- **Placement Opportunities for TCS Students:** Students who are placed with TCS will be considered for additional opportunities, if available.

- **Company-Specific Training:** Training sessions for registered TCS candidates will be conducted by our aptitude trainers on Friday, April 12th, and Saturday, April 13th, 2024.
- **Department-Wise Headcount Submission:** Faculty placement coordinators must submit department-wise registration headcounts to Mr. Santhosh Kumar, Sr. HR Manager, by the end of day (EOD) on April 10th, 2024.

## Nokia 2025 Batch Registration

- **Company-Specific Training:** Training sessions for registered Nokia candidates from the 2025 batch will be held soon.
- **Technical Topics Provided:** Technical topics relevant to the Nokia recruitment process have been shared with all HODs and faculty placement coordinators for reference.

# **Regarding Previous Placement Drives**

- **ECE 2024 Batch Capgemini 5G Shortlisted Students:** The Sr. ED has expressed concern about the performance of ECE 2024 batch students shortlisted for the Capgemini 5G drive. These students reportedly lacked basic knowledge of 5G technology.
- ECE 2024 Batch Placed Students Cientra Training/Placement: ECE 2024 batch students who were placed were allowed to attend training/placement for Cientra without informing or involving the Department of HRD. This is a violation of protocol and should be addressed to prevent future occurrences.

• Offers for 14 students placed in EXL were revoked. These students have been given the opportunity to attend the LG Soft drive on April 10th, 2024.
