ROLES AND RESPONSIBILITIES OF ANTI-RAGGING COMMITTEE

Awareness Programs – Conduct seminars, workshops, and campaigns to educate students on anti-ragging policies.

Clear Communication – Display guidelines on notice boards, websites, and handbooks for easy accessibility.

Campus Surveillance – Monitor hostels, cafeterias, and common areas; install CCTV cameras in sensitive zones.

Complaint Mechanism – Provide a confidential platform (helpline/email) for students to report ragging incidents.

Prompt Investigation – Conduct fair inquiries on complaints and maintain records of actions taken.

Strict Disciplinary Action – Penalize offenders as per UGC guidelines, including suspension or legal action.

Coordination with Authorities – Work with hostel wardens, faculty, and law enforcement if needed.

Student Vigilance – Assign faculty and student representatives to act as anti-ragging vigilance officers.

Counseling Support – Offer psychological help to victims and rehabilitation support for offenders.

Safe & Inclusive Environment – Promote mutual respect and a ragging-free culture on campus.

ANTI-RAGGING POLICIES

The Anti-Ragging Policies at New Horizon College of Engineering (NHCE) align with UGC and AICTE regulations to ensure a ragging-free campus. The key policies include:

Zero-Tolerance Policy

Strict prohibition of any form of ragging, both on and off campus.

Any student found guilty will face severe disciplinary action.

Legal Consequences

Ragging is a criminal offense under the UGC Anti-Ragging Regulations 2009 and can lead to FIR filing and legal prosecution.

Mandatory Undertaking

All students and parents must sign an anti-ragging affidavit at the time of admission, agreeing to abide by the policies.

Reporting and Confidentiality

Students can report incidents through a dedicated helpline, email, or complaint box.

The identity of complainants will be kept strictly confidential to prevent retaliation.

Disciplinary Actions

Depending on the severity, punishments may include:

- Warning & Counseling (for minor offenses)
- Suspension or Rustication
- Expulsion and Debarment from Exams/Placements
- FIR Lodging & Legal Punishment (for serious cases)

Monitoring & Surveillance

CCTV cameras, student vigilance groups, and surprise inspections will be used to prevent ragging.

Anti-Ragging Committee & Squad

A dedicated committee investigates complaints and ensures enforcement of anti-ragging measures.

The squad conducts surprise visits to hostels, canteens, and common areas.

Student Awareness & Training

Regular workshops, orientation sessions, and pledge ceremonies to educate students on anti-ragging policies.

Hostel Regulations

Strict hostel entry and visitor monitoring to prevent ragging-related incidents.

Senior students are strictly warned against harassing juniors.

Counseling & Support

Psychological counseling and rehabilitation programs for both victims and accused students.

Encouraging a positive peer culture to maintain a ragging-free environment.

These policies help maintain safety, discipline, and inclusivity at NHCE


3 Displaying Posters, Rules and Regulations of Anti-Ragging
