- Assistance: Support individuals in recognizing and exercising their rights to freedom and safety.
- Action: Treat sexual harassment as misconduct and initiate appropriate punitive actions against such behavior.
- Support: Assist aggrieved individuals in filing complaints and ensure their protection against victimization.
